**SECTION 7 - HANDLING AND STORAGE**

**Handling Precautions:**

**Precautions for safe handling**

Prevent formation of fine mist and vapor buildup during and after use. Avoid splashes or spray in enclosed areas. Use only in well ventilated areas. Do not get in eyes. Avoid skin contact. Prevent prolonged or repeated breathing of

vapors or spray mist. Avoid breathing of sanding dust. Wash contaminated clothing thoroughly. Wash skin thoroughly with soap and water after handling. Close container after each use. Do not transfer this product to unlabeled containers. Do not handle until the manufacturer's safety precautions have been read and understood. Keep out of reach of children.

**Storage Requirements:**

Do not store above 120 F. Store large quantities only in buildings designed to comply with OSHA 1910.106. Keep closures tight and container upright to prevent leakage. Do not store or use near heat, sparks or flame. Never use pressure to empty. Drums must not be washed out or used for other purposes. Drums of this material should be grounded when pouring.

**Engineering Controls:**
