**Handling Precautions:****Precautions for safe handling**

Prevent formation of fine mist and vapor buildup during and after use. Avoid splashes or spray in enclosed areas. Use only in well ventilated areas. Do not get in eyes. Avoid skin contact. Prevent prolonged or repeated breathing of vapors or spray mist. Avoid breathing of sanding dust. Wash contaminated clothing thoroughly. Wash skin thoroughly with soap and water after handling.
